- **2.** <u>Proposed Tax Levy:</u> Mayor DeNeale reported the proposed millage rate at 2.4979 mils per \$1,000 of Taxable Value.
- **3.** <u>Review Proposed Budget:</u> Mayor DeNeale reviewed the Proposed Budget for October 1, 2020 to September 30, 2021 as follows:

Ad Valorem Taxes	\$1,878,301
Sewer & Storm	1,416,501
Other Revenues	2,217,750
Total Budget	\$5,512,552

The proposed budget represents a millage rate that is 2.9% above the rollback rate.

- 5. <u>Public Comments, Commission Response:</u> There were no public comments.
