2. <u>**Proposed Tax Levy:**</u> Mayor DeNeale reported the proposed millage rate at 2.4979 mils per \$1,000 of Taxable Value.

3. <u>**Review Proposed Budget:**</u> Mayor DeNeale reviewed the Proposed Budget for October 1, 2020 to September 30, 2021 as follows:

Ad Valorem Taxes	\$1,878,301
Sewer & Storm	1,416,601
Other Revenues	2,270,310
Total Budget	\$5,565,212

The proposed budget represents a millage rate that is 2.9% above the rollback rate.

4. <u>Budget Changes:</u> Mayor DeNeale asked if there were any proposed budget changes. No requests were made.

5. <u>Public Comments, Commission Response:</u> There were no public comments.

6. <u>Resolution 2020-03 to Adopt the Tentative Millage Rate:</u> Mayor DeNeale read the resolution to adopt the final millage rate of 2.4979 which is greater than the roll back rate of 2.4275 mils by 2.9%.
