#### **CITY PARKS RENTAL RATES**

Deposit and rental rate must be paid separately: deposit payment to be paid by check or money order ONLY; rental fee by check, money order, or credit card. All fees must be paid when the date is reserved. **Reservation costs are non-refundable.** Deposits will be refunded upon inspection of the premises less any cost required for clean-up. The park is to be left in the same condition as when it was rented, and the contact person listed below shall be responsible for maintenance.

#### **RULES**

- Park usage will only be authorized for wedding vows and photos. (No reception, food or alcohol is allowed - with the exception of a toast.)
- The maximum number of people attending the event is 20 people.
- Our Hold Harmless Agreement must be completed, signed and dated.
- A Certificate of Liability Insurance must be provided naming the City of Key Colony Beach as an Additional Insured.
- Hours of use include decorating/set-up and clean-up time. Please note that Sunset Park closes at Sunset, and the time of Sunset changes throughout the year. No exceptions will be made to extend Park hours for special events.
- Set-up & re-arranging of benches/tables by Public Works staff will be at a rate of \$75.00 per hour.
- All renters are responsible for general clean-up and trash removal. A dumpster is NOT provided.
- Additional parking is available down the street at Gazebo Park, or you may contact the nearby Continental Inn to ask for permission to park in their lot. There is no parking on private property.
- Sunset Park is a public park and will remain open to the public during special events. Renters cannot request anyone to leave the park.
- The rental fee can be waived for a Bride or Groom who is an Owner or long-term renter of Key Colony Beach, with appropriate proof. The deposit fee will not be waived.
