A Notice of Commencement must be filed with Clerk of Court, and recorded copy submitted to Building Department prior to first inspection, if the job valuation is greater than \$5,000 (FS Section 713.02(5)). This does not apply to a direct contract to REPAIR or REPLACE an EXISTING heating or air-conditioning system in the an amount less than \$15,000 (FS Section 713.135(d)), or to any political subdivision, agency, or department of the state, a municipality, or other governmental entity.(FS 713.01(23))
