**WHEREAS**, the City of Key Colony Beach, Florida seeks to repeal Resolution 2023-18, which established official email addresses for City Commissioners; and

**WHEREAS**, City Commissioners must efficiently access and send emails to comply with Chapter 119 of the Florida Statutes and to conduct City business; and

**WHEREAS**, each commissioner, upon being sworn in, will provide the City Clerk with an email for public use and to list on the City's website. If any Commissioner wishes to have an email assigned by the City one will be provided; and

**WHEREAS**, the City Commission finds that permitting Commissioners to select their preferred email platforms is in the best interest of the City and its residents.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY COLONY BEACH, FLORIDA AS FOLLOWS:**

**Section 1.** The above recitals are true and correct and incorporated into this Resolution by this reference.

**Section 2.** The City Commission hereby approves the use of Commissioners' preferred email addresses and platforms for official communication.

**Section 3.** The City Administrator is hereby authorized to take all necessary action to implement designated email addresses and effectuate the intent of this Resolution.

**Section 4.** This Resolution shall go into effect immediately upon its passage and adoption.
